FINANCE

Transparency is the key for growth at HCC, and with that addressing overspending proactively is what is needed. The club can then take steps to regain financial stability and foster a culture of responsible financial management for its members.

We have exceeded our budget in our supplies categories in Bar & Damp; Kitchen and General. We are projected to exceed our budgeted regular pay line this fiscal year in the Bar & Kitchen. We have exceeded regular pay in the pro shop already to date.

We need to trim excess spending in certain areas for growth and sustainability. We are a business. We must make money and grow for the membership to have more amenities.

Revenue Generation Strategies

In our pursuit of sustainable growth, we have implemented several revenue-generation strategies to diversify income streams and maximize profitability. These include:

- Introducing new membership tiers with enhanced savings to attract a broader range of golf enthusiasts.
- (2) 10 years, (4) 5 year and (3) 3-year deals left
- Ad revenue from tee markers and scorecard advertisement.

These efforts have yielded promising results and positioned the golf course for continued growth in revenue for months and years to come. These efforts have lowered our overall debt by roughly 18%.

Cost Management

While revenue growth is essential, effective cost management is equally critical to maintaining financial health. Here are somethings your HCC board is working on for controlling costs and optimizing operational efficiency:

- Regularly review expenses to identify areas for savings and negotiate favorable terms with suppliers and vendors.
- Cross-train staff members to maximize productivity and minimize the need for external hires during peak seasons.

By proactively managing costs, we can ensure the long-term sustainability and profitability of the golf course.
